
- Robert's Rules of Order

ASSEMBLYMEMBER ADAM GRAY'S MEDICAL WORKGROUP

- UCMAA Board Member Domonique Jones
 - Discussion was held with the office of Assemblymember Adam Gray
 - A report was completed regarding the potential establishment of a medical campus in the Merced area. The report reflected the need of a medical campus in the San Joaquin Valley and that the general public was accepting of the idea.

- 2. <u>AB2202</u> was signed into law to create an endowment fund to establish a UC-based medical school campus in the San Joaquin Valley.
- 3. There is interest by a specific group of managed care provider networks to donate to the cause. There is also expressed interest from private donors.
- 4. There was a UC Merced Medical Workgroup before, however, with the new administration is hoping to rebrand the workgroup and is willing to offer a seat to the UC Merced Alumni Association. More information to be discussed at an upcoming April follow-up.

• Open Discussion:

- Miguel Lopez: Who will be staffing the workgroup?
 - 1. Domonique Jones: Staffing has yet to be determined and requires further discussions with Adam Gray's office.
- Randell Rueda: SJV PRIME was produced as an initiative through the UC Medical Schools as a stepping stone for a medical campus in the San Joaquin Valley, through joint efforts from UC Merced, UCSF-Fresno, and UC Davis as the home institution.
- Miguel Lopez: Is there follow-up with Adam Capper?
 - 1. Domonique Jones: Yes. Follow-up with Adam Gray's office will be completed in April and information will be relayed to the board at large.



- Career Fair Support
 - Jacob Gutierrez: Is there support to create a new fund to help students participate in career events such as the career fair?
 - Miguel Lopez: How many trips would be sponsored?
 - Chris Abrescy: Would be one-off situations. The Student Affairs Emergency Fund (SAEF) helps students in times of crisis. The new fund would help students attend fairs such as the USC Multi-University Alumni Career Fair held in March.
 - Brandon Ruscoe: How would support be given?
 - 1. Chris Abrescy: Different ways of support can be provided such as gift cards or sponsoring travel.
 - Marko Zivanovic: Could this be further discussed in the Career & Professional Advancement committee alongside Brian so that key student events can be identified in the coming months, and process for disbursing funds may be discussed?
- Chris Abrescy: What is the consensus on the funds in current use? Funds can be used to increase the scholarship amount awarded or the number of scholarships given.

- Summer UCMAA Board Meeting
 - Marko Zivanovic: Can the meeting be held around the same time as a Dinner with the Deans in San Francisco? Can the meeting be moved to earlier in July and potentially held in McKinsey?
- Alumni Regent Selection
 - Keith Ellis: In, 2022 there will be an opportunity to select a Regent. A proposal should be crafted within the next year for consideration.
- UC-Wide Events
 - Chris Abrescy: A lot of administrative changes have occurred at UCOP so events have been paused for the time being. It has been a few months since John Valva moved on from UCOP and it is unclear if his position will be filled.

 - Chris Abrescy: A lot of the event funding is provided by the division of External Relations, however, it is unclear how long this will continue.
