

SEARCH COMMITTEE TIMELINE | 2021 - 2022

TIMELINE

January 30, 2021	UCMAA Board reviews initial draft of Selection Process Bylaws, provide feedback, and make edits.
March 25, 2021	UCMAA Executive Committee hosts additional meeting with UCMAA Board to review updated Selection Process Bylaws draft.
April 5, 2021	Final draft reviewed by ER Vice Chancellor.
April 9, 2021	Final draft reviewed by Chancellor.
April 24, 2021	UCMAA Board of Directors vote on final Selection Process Bylaws.
May 31, 2021	Finalize Oversight Committee Meeting Schedule, Ranking Criteria, Rubric, and Interview Questions for candidates.
June 30, 2021	Finalize Meeting Logistics.
July 1, 2021	Open Alumni Regent Applications.
July 1, 2021	Alumni Relations sends invitations to first set of Oversight Committee Members: UC Merced Vice Chancellor, UC Alumni Regent, UC Merced Director of Alumni Relations, UCMAA Board President.
August 30, 2021	Alumni Relations sends invitations to second set of Oversight Committee Members: (2) current UCMAA board members (designated by UCMAA executive committee), (1) Alumni Association member at large (designated by the UCMAA executive committee), and (3) student representatives (ASUCM, SAA, GSA).
September 6, 2021	Alumni Regent Application was extended until midnight.
September 7, 2021	Round 1 Begins...
September 7, 2021	All applicants are notified of the three-step process and timeline. Candidates will be notified by 10/1/21 if they have been selected for round 2.
September 30, 2021	Complete Round 1: Application Review. Selection Committee identifies the top 3 candidates to go through additional vetting process.
October 1, 2021	Notify candidates of their status. Ask top three candidates to send list of potential dates/times between October 1-30 for interviews via zoom.
October 2, 2021	Round 2 Begins...
October 15, 2021	Over the course of a week, the Oversight Selection Committee will host interviews with candidates.
October 30, 2021	The Selection Oversight Committee will send a list of top candidates to additional groups for optional recommendations (Staff Assembly and Academic Senate).
October 30, 2021	Complete Round 2: Campus Leadership will review candidates and submit their recommendation to the Oversight Selection Committee.
November 15, 2021	Round 3 Begins...
December 15, 2021	Complete Round 3: The Selection Oversight Committee will review submitted recommendations for final candidate selection and create a presentation to share with the UCMAA Board for final confirmation vote of selected candidate.
January 17, 2022	Summary of results submitted to Chancellor for final review.

February 5, 2022

The top candidate is presented to the UCMAA Board for review and vote.

February 7, 2022

The UCMAA Board's decision is submitted to Chancellor.

February 11, 2022

The Selection Oversight Committee will inform final candidates of the outcome. Once the Regent-Designee confirms, they will be invited to attend the upcoming UCMAA Board and Regent meetings.

March 18, 2022

Official announcement of the Regent-Designee.

April 2022

Designee will attend the UCMAA Board Meeting.

May 2022

Designee will attend the Regent meeting; The Alumni Regent-Designate is welcome to attend this meeting to observe as a guest.

July 1, 2022

Alumni Regent-Designate's term officially begins.

July 2022

Regent Meeting – First meeting as Alumni Regent-Designate.
